

July 20, 2016

The Saratoga Town Board met at 6:00 p.m. in the town office. Chairman Rickaby called the meeting to order. All members were present. The meeting was officially noticed.

Forbes made a motion to approve the minutes for July 6<sup>th</sup> and July 14<sup>th</sup>, 2016. Passineau seconded it. Motion passed.

Frank made a motion to adopt Resolution #2016-2. The Resolution is requesting that the Governor and Legislature to agree upon a solution that includes a responsible level of bonding and adjust user fees to adequately and sustainably fund Wisconsin's transportation system. Forbes seconded it. Motion passed.

Tony Berger would like the Board to approve the addition to another building to his current beverage license. He would like to add the building at 6421 Hwy 13 South in addition to the 830 Townline Road. The buildings are on the same parcel of land. The Board is concerned about the first driveway on Townline Road since it is so close the Hwy 13 intersection, and about parking outside of the building on Hwy 13 interfering with the visibility at the intersection. With the building being open to the general public, the Board wants to ensure the safety inside the building. Passineau made a motion to table the issue until the Town is able to speak to Tony in person and are able to get a business plan from him. Forbes seconded it. Motion passed.

Heeg made a motion to adopt Ordinance 7-20-16; Ordinance relating to the issuance of citations for violations of town Ordinances. The building code ordinance number was changed it reflect the adoption of that new ordinance. Frank seconded it. Motion passed.

Lorelei Fuehrer gave the building inspector's report. The building at 6421 Hwy 13 was discussed. Lorelei said that the building is not a commercial establishment. If the Town wanted him to be up to commercial specs, the State inspector would need to come out and see the upgrades that have been done. The building he is using now at 831 Townline was supposed to be mainly just for friends coming in to his shop, now that he is expanding and wants it to be open to the general public should be up to code.

Dave Ryun gave the Constable's report. Ken Jaecks was just found guilty of violating of the nuisance ordinance at municipal court. He was ordered to pay \$691 for the first offense and \$1951 for the second offense. He is required to have a clean-up plan to the Town hall office by 5:00 PM on July 22<sup>nd</sup>, 2016.

The notice for the clean-up of Strangfeld's property on Hollywood Road was in the paper. Eight dog citations will be issued.

Out of approximately 20 properties the Town was notified had items with the right-of-way, only 1 property still needs to get the items removed.

A complaint was received by Holewinski on Pine Haven Court. Their neighbor has a few cars on the property that are not licensed. He has until the 22<sup>nd</sup> to remove the cars or a ticket will be sent.

John Sweet has shown progress on the clean-up of his property. The Board extended his clean-up until 9-1-16.

Dennis Trickle has shown some progress on his property. He has until 8-1-16 to get his property clean according to his plan.

Billie-Jo gave the Treasurer's report. The garbage and recycling for the boundary agreement area was discussed. The developers said that they were going to have a one pickup point in the subdivision, but one has not been set up. People living in that area are looking for direction on how to get pickup. The Town would like to have a written letter by the Pavolski's

stating that the Town would not be held liable for any damage done to the private roads by the garbage trucks in the boundary area if the garbage pickup was contracted through the Town.

Correspondence was read.

Road work on Bell Road should start approximately on August 8<sup>th</sup>.

If there is enough money in the budget after the road work on Bell is finished, the Town will look at working on fixing some of the dips on 52<sup>nd</sup> Street between Church and Mill.

Passineau made a motion to approve the bills paid. Heeg seconded it. Motion passed.

Frank made a motion to adjourn the meeting. Heeg seconded it. Motion passed. The meeting adjourned at 7:30 p.m.
