Passineau made a motion to grant the request. Heeg seconded it. Motion passed. Questions were brought up about the reserve licenses that the Town is able to grant. The clerk will check to see if the money for the license that was given to the Town has to be returned and if the reserve license will transfer to a new bar owner.

Implementation of Husbandry paperwork was given to Board members. It will be discussed at the next meeting.

There was a complaint about things being placed in the right of way on 52nd Street. Although it is at the end of a private trail, it is still within the Town road right of way and cannot be placed there. A letter was sent by the Constable to the owner of the items letting him know this. He has gotten no response. If he finds that items are placed there again, a citation can be issued.

The Board discussed portable signs. There are quite a few portable signs and trailers that advertise within the Town. The Town has to have some way to enforce the sign ordinance. Forbes requested the Constable and Board come to the next Plan Commission meeting to discuss it together.

The business at the corner of Hwy 73 and Hollywood has put up no parking signs and banners along Hwy 73 within the road right away.

Dave Ryun gave the Constable's report. He has received one email from the Humane Society regarding dogs that have been picked up.

The junk that was picked up in Plum Creek's fire lanes is still there. Dave will send them a letter letting them know that it needs to be cleaned up, Terry will get him contact information.

Ken White has about 50 more tires on his property. He has gotten a few tickets from the Town in the past about the tires and other items. Dave will send him a ticket for violation of the nuisance ordinance.

The Towns' lawyer is dealing with Dean Folts for the unpaid forfeitures and violations of the nuisance ordinance.

Passineau discussed utility permits with the Board. He said that it would be nice to require permits so the Town will know where boring or working within the road right of way is being done. The Town will check with the Towns Association. It will be placed on the next agenda.

Frank stated that the containers on Hwy 73 are all different colors and are pretty close to the road. The Board wants to check conditional use paperwork and have them come to the next meeting.

Lorelei Fuehrer gave the Building Inspector's report.

A group of people from the Protect Wood County group and two men from the Town that are collecting data from streams within the Town and giving the information to the DNR and University of Wisconsin met with John Jansen. He was very impressed with all the records and information that they had collected. It will be useful in researching and creating his report.

Billie-Jo Kester gave the Treasurer's report

Correspondence was read.

Heeg made a motion to approve the bills paid. Passineau seconded it. Motion passed.

Frank made a motion to adjourn the meeting. Passineau seconded it. Motion passed. The meeting adjourned at 7:55 p.m.
