ATTENTION ALL DOG OWNERS- DOG LICENSE DUE DATE IS MARCH 31, 2018

Dogs more than 5 months old within the license year must obtain a dog license. **All dogs must be inoculated for Rabies and must be licensed under penalty of law.** (ss.174.05 (10)). No license will be issued without proof of rabies inoculation certificate. Licenses are due MARCH 31, 2018, any license sent after that date will have to pay an additional **late fee of \$15.00 per dog.**

That same \$15.00 charge will be given to anyone getting a 5-day ticket for not having their dog licensed.

You MUST have the **rabies certificate for each dog with your current mailing address written on it.**

LICENSE FEES are: Spayed Female/Neutered Male \$3.00 (If late, **add \$15 per each dog**)

Female/Male \$8.00 (If late, **add \$15 per each dog**)

Multiple (1 to 12 dogs) \$35.00 + \$3.00 over 12. (If late, **add \$15**)

Citations will be issued to dog owners or keepers of unlicensed and/or dogs running at large

If you are using mail or one of the banks listed above when paying, I will return, by mail, all rabies certificates along with the dog license.
